

TERMS & CONDITIONS:

- Non-refundable costume deposits in the amount of \$50.00 for recreational classes, \$75 for part-time competitive classes and \$100.00 for competitive classes are payable per class (excluding ten-week sessions and competitive ballet/tech classes) at the time of registration.
- A registration fee of \$20.00 per person or \$25.00 per family is due at the time of registration for all programs.
- If choosing the monthly payment option, we require first & last month's fees at the time of registration along with registration fee & costume deposit. Oct-May's fees are due on the 1st of every month and can be paid in the form of a pre-authorized credit card payment.
- If paying in two instalments, we require the first instalment at the time of registration along with costume deposit and registration fee. The second instalment is due by no later than February 1st, 2018.
- **There are absolutely no refunds for missed classes or for those who choose to quit the program.**
- Late charges will apply to all outstanding fees. A 10% late fee will be applied after 30 days and after 60 days the dancer may be removed from the program.
- There will be no refunds for classes cancelled due to severe weather conditions or if a student misses a class. Classes are only cancelled if weather conditions are extreme – you will be emailed if we decide to cancel classes and a message will be left on the answering machine.
- Please notify the office of any change of address and phone number. **Please make sure you give the studio your email address so that you may receive updates and important information throughout the season.**
- Students leaving money or valuables in the change rooms do so at their own risk. JDI is not responsible for lost or stolen items.
- **All recreational and competitive students will participate in our year-end recital. Please notify us in advance of any conflicts. There will be two shows – each class will perform in one of the two shows.**
- Students must respect their teachers and peers at all times – negativity of any sort will not be tolerated.
- Students 12 & under are not to be left unsupervised at the studio when they are not in class – we are not responsible for children left unattended. We ask that everyone respects the premises and clean up any mess left behind – anyone caught vandalizing the property will be responsible to pay for any damages incurred.
- We expect all students to arrive to class on time and to be picked up when the class is scheduled to finish.
- Competitive students will be given a list of guidelines that must be followed in order to remain competitive and may be removed from the program if these guidelines are not adhered to – no refunds will be issued. All students who are new to the competitive program will be accepted on a trial basis for the first two months. IT WILL BE THE DIRECTOR'S DECISION AS TO WHICH STUDENTS WILL PARTICIPATE IN COMPETITIVE CLASSES AS WELL AS SOLOS DUETS AND TRIOS. DISPUTES TO THESE DECISIONS WILL NOT BE TOLERATED.
- Pictures and/or video of students will be taken throughout the season and may be used for advertising purposes.
